Voting in Brandermill

Part 1 of 3: Property Categories, Total Votes, & How Many Votes Needed to Amend

When important votes come up to a community, residents often wonder how their vote impacts the overall picture of an election or a covenant referendum. Each member property in Brandermill, both residential and commercial, has the right to cast votes for board member elections and covenant referendums. However, the number of votes each property owner has is dependent on the amount paid in annual assessments. The number of votes is based on the formula that for every \$100 paid in assessment the property owner gets one vote. The residential annual assessment is currently \$484, which means each residential improved property gets 5 votes. In the case of commercial properties, the assessment amounts varies based upon their respective commercial membership category. There are three different categories for commercial properties and each category's assessment formula is different (example: based on acreage

or square footage). The formulas determine what they pay in assessments; thus their number of votes varies accordingly.

There are a total of 3,942 properties in Brandermill and their vote allocation is based upon the aforementioned respective category assessment formulas.

approve are required in order to amend the covenants.

In order to amend the covenants, a regular meeting of the Association or a Special Meeting of the Association is required to be held. Such meetings are NOT a meeting of the Board of Director's (the meeting is held BY the Board on the first Monday evening of each month). At a meeting of the membership, **quorum is 20% of the total number of eligible votes** of the membership - present, either in person or by proxy. With 21,795 total eligible votes, that means **quorum is 4,359 votes** - again either present in person or by proxy/ballot. **It does not mean 20% of those who physically show up at a meeting.** Of the minimum number of votes required to reach quorum (4,359) it currently takes a minimum of 75% of that amount to approve a change to the covenants. This means **a minimum of 3,269 votes to**
